Fiscal year 2023-2024 (FY23-24) was truly a year of change for The Mediation Center of the Pacific (MCP). We bid Aloha to valued staff members who moved on to exciting new adventures, and long-time board members whose terms came to an end. We also integrated a new mediator scheduling system to increase efficiency, strengthened partnerships and programs, and grew the Early Eviction Mediation Program (EEM) to assist more tenants and landlords. The MCP Team, Board of Directors, and mediators all contributed to meet the challenges and embrace the changes.

said "Change brings opportunity." MCP's FY23-24 is a testament to that quote. The many changes MCP experienced led to the opportunities of adding outstanding new staff and board directors, enhancing programs, and conducting more training. And most importantly, embracing the many changes enabled MCP to be stronger and make a bigger impact on Oahu's communities. 1,573 cases were mediated with a higher rate of written agreement from prior years, as well as a significant increase in positive feedback from the mediation participants.



MCP could not have accomplished these outcomes without the committed support of the donors who gave generously throughout the year. Together we served 12,203 people. And by helping these individuals prevent and resolve conflicts through mediation and training, their lives were improved, relationships were restored, families were strengthened, and housing stability was increased. While MCP didn't fall apart in FY2324, losing key staff while simultaneously upgrading technology systems and managing a continued high volume of cases, made

daily operations challenging. Despite the challenges, the MCP Team pulled together to strengthen programs, accomplish projected outcomes, and more.

## **Domestic Mediation**

MCP continued to manage a high volume of requests for domestic mediations involving custody and time-sharing of the children, as well as division of property. 520 domestic cases were mediated and 254 couples reached written agreements. A significant increase from prior years. These outcomes

were achieved by providing mediators with more specialized training and support and developing an enhanced collaboration with the Family Court Judges and the Family Law Section of the Hawaii State Bar Association (FLS).

Thanks to increased training and support, the rate of agreement for domestic mediations increased from 40% in FY22-23 to 49% in FY23-24.



Special workshops and training for the mediators touched on a broad range of topics including trauma informed strategies to effectively de-escalate intense emotions and hostile behaviors; tools for working with couples in the military; strategies for incorporating court forms and supporting documents to help couples negotiate equitable agreements; and approaches for negotiating custody when one or both parents are relocating.

To support the collaboration with the FLS and the courts, MCP hosted the first Bench-Bar-Mediation discussion through a hybrid

gathering; 59 Judges, attorneys, and mediators participated in the discussion. The participants agreed that the event was valuable and a good step towards further strengthening MCP's domestic mediation program.

### **District Court Mediations**

Thanks to great mediators and longer mediation sessions, the number of District Court cases mediated increased significantly over the past few years, as well as the rate of agreement.

The District Court cases managed by MCP increased significantly over the past four years. In FY2324, MCP opened 1,300 cases from the District Courts (Small Claims; Landlord-Tenant; Regular Claims; Restraining Orders) in the First Circuit. This number represents 124 more cases than the prior fiscal year and 635 more cases than the total number of District Court cases managed in 2019. 942 of the District Court cases were mediated with 498 or 53% resulting in written agreements (a 6% increase in written agreements from the prior year). The higher rate of agreement was due to

They played a major role in getting this case settled." -Small Claims Mediation Participant added mediator support combined with the fact that the District Court mediations conducted at MCP provided more time for the parties to negotiate, as opposed to the twentyminute mediations previously conducted onsite at court.

### Landlord-Tenant Mediation: Increasing Housing Stability

Hawaii's high cost of living has contributed to historically high numbers of landlord-tenant disputes and eviction filings. Through mediation, in FY2324, 650 tenants and landlords were helped to talk with each other and negotiate 404 agreements that resolved their differences, enabling them to avoid a legal proceeding. Equally important, thanks to the support of private funders, MCP continued to promote early mediation between landlords and tenants, before a legal action was filed. As a result of these efforts, in FY2324, 91 mediations were conducted before the landlord filed a claim, and 79 cases or 87% of the early mediations resulted in written agreements.



In May, MCP received the 2024 Emil Gumpert Award from the American College of Trial Lawyers to support the Early Eviction Mediation Program.

Due to the successful outcomes of the early eviction mediation program (EEM), in May 2024, MCP received the prestigious Emil

Gumpert Award from the American College of Trial Lawyers. The award will enable MCP to grow the EEM program and help more landlords and tenants negotiate payment plans and avoid the eviction process.

# Creating a Culture of Early Problem Solving in the Schools and Workplaces

In a recent study conducted by DDI, a global leadership company, it found that 49% of emerging leaders struggle with managing conflict in the workplace. This study reinforced the importance of MCP's work providing management and employees alike with conflict resolution and mediation

skills. In FY2324, MCP staff and mediators conducted 268 hours of training for Kamehameha Middle Schools, the Hawaii Department of Education Administration, the Leadership Team of the Outrigger Canoe Club, the International Fisheries Division

of the National Oceanic and Atmospheric Association regional office, the Hawaii State Judiciary's Appellate Mediation Program, and more. The participants uniformly agreed that they would use the skills they learned professionally at work, as well as personally at home.




To grow the EEM program and inspire more tenants and landlords to mediate early, Special Programs Innovator Roberta Hickey-Gómez has
